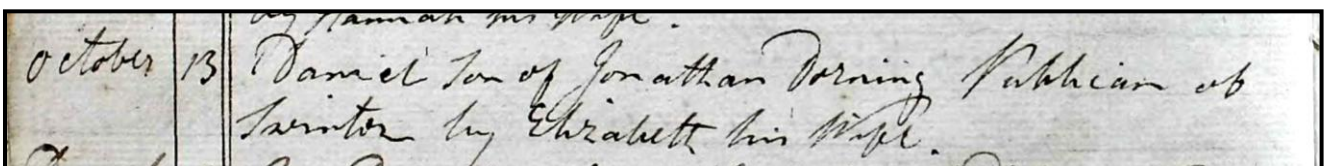
DANIEL DORNING Surgeon Swinton born September 12th 1811 died January 4th 1868

Daniel Dorning was baptised at St. Peter, Swinton, on 13 October 1811, the son of Jonathan Dorning, Publican. In the 1836 UK Poll Book and Electoral Register, Jonathan's name appeared as living at the White Lion, Swinton, in the area known as Ringlows. **Daniel** was the brother of *Elias Dorning*, also buried in the churchyard.

Daniel married Jane Longshaw at St. Mary, Eccles, on 11 April **1838**, by licence. By this time, he had already qualified as a Medical Practitioner, having successfully satisfied the Court of Examiners at Apothicaries' Hall on 28 August **1834**.

The census of **1841** gives very little information, apart from name, Approximate age and district where they lived.

In the *Provincial Medical and Surgical Journal* of **1848**, he presented an article which began: *In advocating the use of flour in burns, my testimony will not be duly estimated, except I state that before I entered upon practice in my own account, I had been accustomed to see burns and scalds treated by another method. I was an apprentice to Mr. Robert Thorpe, one of the surgeons of the Manchester Royal Infirmary in which institution burns were formally treated. ... Just before settling at Swinton, I had read a pamphlet on the efficacy of flour in burns and scalds, and was very much struck with the facts contained within it, and shortly afterwards having been called to some colliers who were severely burnt by an explosion in a mine, I determined at once to make a trial of it. Accordingly, I applied it to the patients very freely, and was so much surprised at and so well satisfied with its effects, that I have continued to use it ever since.* He then proceeded to give, as examples, this treatment to two colliers of the Earl of Ellesmere (in December 1843), Samuel Harmer of Pendlebury (in March 1844) and Margaret Lloyd of Pendlebury (in August 1840).

The name Radcliffe was the maiden name of Daniel's own mother, Elizabeth Radcliffe. His parents, Jonathan Dorning and Elizabeth Radcliffe had married by licence at St. Mary, Eccles, on 24 January 1809. They had nine children - 5 sons and 4 daughters.

The London and Provincial Medical Directory for **1855** recorded: *Daniel DORNING, of Swinton, Manchester. M.R.C.S. Eng, 1835. L.S.A 1834. Certifying Surg. under the Factories' Act. He had successfully satisfied the Court of Examiners at Apothicaries' Hall on 28 August 1834.*

The *Preston Chronicle* on Saturday 21 July **1855** reported on the opening of the new baths at Whittle-le-Woods the previous Wednesday.

Our Lancashire readers know that they now have within their own county, and almost at their own doors, alkaline and chalybeate springs, equal in health-restoring qualities to the famed springs of Harrogate, or the still more famous ones of Baden-Baden. The discovery of these springs was the result of accident. In December, 1845, two gentlemen (William Brigham, Esq., R.H.C.S. and John Heys, Esq.) had been on an excursion to Whittle-le-Woods, and on their return stopped at the springs and refreshed themselves by drinking the water. Fortunately, the former gentleman was struck by its peculiar flavour, and suggested that it would be desirable to ascertain whether it might not possess medicinal qualities. Various trials were made, the water was analysed by an eminent chemist, and its composition accurately ascertained, and very soon afterwards the fame of the good it had effected rapidly circulated, and in a short time a number of invalids hastened to test its qualities and share its benefits. The solitude soon became peopled by a rapidly increasing population, some only meditating a temporary sojourn, while others remained to form the nucleus of what has since become a populous and thriving community

The occasion was one of great joy for the community. Special trains brought visitors to the area to witness the celebrations, beginning with a cricket match, followed by an archery contest and boating on the river. Others enjoyed games of bowls, before a dinner with 200 guests at a local hotel.

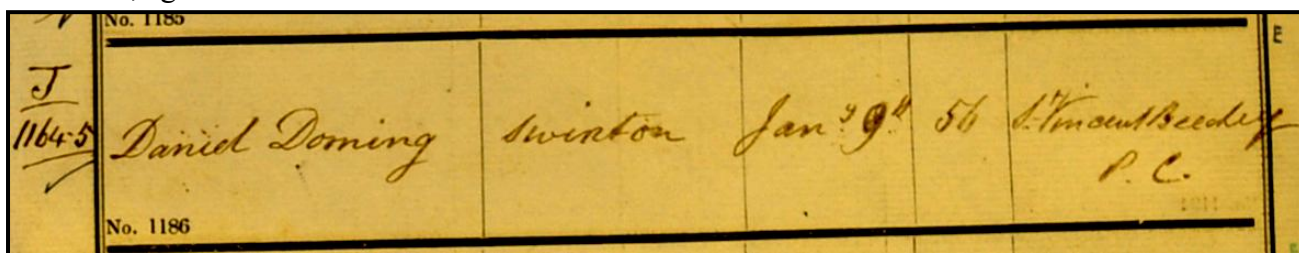
After dinner, Dr. Doming, in an eloquent speech, expatiated upon the medicinal qualities of the water of the springs, the discovery of which has already been of so much Importance, not only to the county, but to the whole north of England.

The youngest son **John Dorning**, born 28 December **1850**, died on 14 September **1893**. His address in his will was recorded as Briar Cottage, 77 Chorley Road, and his effects were left to Charles Brockett Grover, Gentleman, and William Fitzwilliam O'Grady, Surgeon.
