

# **Rev. Charles Spencer** – (c.1816 - c.1881)

(*Curate* - Feb 1871 to Jul 1872)

c1816: Born Cambridge. Son of John Spencer.

**1828** to **1833**: Educated at Huntingdon Grammar School.

Receipts for board and education of Master [Charles] Spencer at Huntingdon 1828- MC
Grammar School, with letters to John Spencer from J. Fell and James 1833 2782/C/1/2
Blomfield about his progress

**1834:** Admitted to PEMBROKE COLLEGE, Cambridge, **1834**. Awarded BA in **1838** and MA in **1843**.

**1835:** *Katherine Blanche Bulwer*, future wife of Charles Spencer, was baptised at Cawston, Norfolk, on 9 June 1835. The daughter of Augustin Bulwer and Mary Blanche Bulwer.

Ordained Deacon in 1840 and Priest in 1843 by the Bp. of Norwich.

**1841** census: Boarder on Hungate Street, Aylsham (25). Clergyman at Aylsham, Norfolk. NOT born in the county!! (St. Michael & All Angels). The home of Elizabeth Nobbs (70), Postmistress.

Ordination of **Charles Spencer** as deacon and priest by bishop of Norwich, **1840-** MC with statement by his father as to his date of birth, and by master of Pembroke **1843** 2782/C/2/3 College as to his suitability for ordination





**1937:** Arrival in London on 16 April **1937** from Demerara of Amy Wade (75), Olive M. (52) and Mary C. (53), all from St. Ktts.

Amy Blanche Wade herself, aged 85, was buried in the same graveyard at Snowshill 20 months later.

The other daughter Olive Muriel Wade was also buried at Snowshill, 10 March **1958**, aged 73 years. She had been living in Reading.

So, how can we account for the intriguing lives of this family following the death of **Rev. Charles Spencer** in **1878**? The following information has been taken from the internet, and is not the product of my own research.

The whole story originated with the birth of *Paget Augustus Wade* [future husband of *Amy Blanche Spencer*] in St. Kitts, West Indies, in **1849**. He subsequently died on 25 December 1911 in St. Kitts. He was the son of Solomon Abraham Wade and Mary James. According to the DNB entry for his grandson *Charles Paget Wade* [who later married Amy Blanche Spencer], Solomon Abraham Wade was "originally a successful dry goods supplier on St Kitts in the West Indies, [and] had acquired sugar cane plantations on the island that established the family's fortune."

According to an unsourced online family tree, the family had three estates in St. Kitts (White House, Mansion and Codrington) and were connected to the shipping company Sendel [=Sendall] & Wade. Their third son *Paget Augustus Wade* inherited the estates as his brothers died before him. *Paget Augustus* was described as a merchant of 34 Fenchurch Street, City of London, when his father's will was proved in **1882** and was a "West India Merchant" in the census of **1891** when he was living with his mother in Teddington, Middlesex.

Upon the death of *Paget Augustus Wade*, his son **Charles Paget Wade** (1883 - 28 June 1956) "inherited a substantial interest in the family sugar estates, enabling him to devote the rest of his life to his own pursuits, and more immediately to art and illustrating." He was born at 9 Scotts Lane, Shortlands, near Bromley, Kent on 13 February **1883**. **Charles Paget Wade** spent part of his inheritance buying Snowshill Manor in the Cotswolds, which he extensively restored and used as a living museum for his "spectacular collection of everyday and extraordinary objects from across the globe". His mother Amy Blanche **Spencer** (1858-1943) was the elder daughter of Rev. **Charles Spencer** (1816-1878) and Katharine Blanche Bulwer (1835-1927), a descendant of a junior branch of the Bulwers of Heydon and Wood Dalling.

# **Grannie Spencer**

*Paget Augustus* married *Amy Blanche Spencer* (1858-1943) in **1882**, and the following year their only son Charles was born in Kent. When Charles was seven years old, he was sent to live with his grandmother, known as Grannie Spencer, in Great Yarmouth. [v. 1891 & 1901 censuses above]

#### **Grannie's magical cabinet**

Grannie Spencer lived a spartan existence and was strict with Charles, but she also owned many interesting artefacts and curiosities. She kept these in an exquisite 18th-century lacquered cabinet.

She would allow Charles to open the cabinet with its 'magic key' every Sunday, to marvel at its collections, hidden within its drawers and recesses.

# **Family treasures**

The cabinet contained old 'family treasures', like a little wax angel with golden wings, musical boxes, shells, compasses, butterflies and silver spoons.

#### Sentimental value

'Grannie's Cabinet' was of great sentimental value to Charles and was thought to be the inspiration for his own collecting. His first acquisitions, bought with his pocket money, were three small bone-carved shrines of St Michael and two of the Virgin and Child.

#### The First World War

Conscripted to serve in the war in 1916, Charles was then called up as a Sapper in the Royal Engineers in 1917. Unsuited to army life and seeing devastation all around, Wade turned to painting and drawing as a way of escaping the atrocities of war.

He depicted ruined landscapes as whole again and created scenes of fantasy gardens.

# A chance discovery

Assigned the duties of Orderly Room Clerk, Charles dressed and decorated his accommodation to recall the comforts of home. While working in France, he happened to discover a Country Life magazine that included a notice for the sale of Snowshill Manor at auction.

#### **Moving into Snowshill Manor**

After the First World War, Charles purchased Snowshill Manor and Garden, which was in a terrible state of repair. He restored the house and turned the farmyard into an Arts and Crafts garden with the help of his friend and architect Mackay Hugh Baillie Scott (1865–1945).

#### A home for his collection

While his collection took pride of place in the manor house, Charles set up home in the small Priest's House opposite. Word of his collection soon spread among writers and artists, and he welcomed several famous figures to Snowshill in the early 20th century. They included J B Priestley, Virginia Woolf, Graham Greene and even Queen Mary.

Charles created his own coat of arms, which bore the motto 'Let nothing perish', which was an overt statement on his passion for collecting and craftsmanship.


