



As you enter the churchyard from the main car park, turn right and follow (carefully) the perimeter fencing and the vaults and stones along it. You will quickly come across a very large, square slab of black marble laid flat on the ground. The etching is very clear and there is an etched border around it. It bears the names of John and Anne Sophia Laycock, with Liliam Laycock; and also Clara Sophia (Gill) and Elsie Clara (Gill).

John LAYCOCK

John was born on 15 February **1825** in Sabden, near Whalley. He was 'registered' at the Baptist Church there on 20 November **1826**, and was the son of **Joseph** and **Martha** (Entwistle) Laycock. On the same day of his registration was also Grace Laycock, a sister, who had been born on 17 August 1822. His father, Joseph, was a Printer.

Joseph Laycock married Martha Entwistle in Whalley on 9 March 1822.

In the same census, **1871**, Martha was living at 100 Elizabeth Street, Cheetham, aged 68. With her were Grace 48; Martha E.23; Edmund 36, a Warehouseman; and James 34, a Yarn Dealer. All 4 were unmarried. Ten years earlier, in the **1861** census, she was living at the same address, with 3 of the same children. William (29) was there at that time, but Martha E. was not.

Martha (Entwistle) Laycock died on 18 February 1878.

John Laycock died at Broad Oak Park on 23 November **1894** and was buried in the churchyard on 27 November. He left a substantial will.

The *Ilustrated London News* of Saturday 16 March **1895** reported:

The will (dated Fob. 23, 1893) with a codicil (dated Aug. 13, 1894) of Mr. John Laycock, of Park Hill, Worsley, near Manchester, Merchant, who died on Nov. 23, was proved at the Manchester District Registry on Jan. 21 by Edwin Holme, Frederic James Randall, and John Thomas Doyle, the executors, the value of the personal estate amounting to £23,865. The testator bequeaths his furniture and effects for life, and £500 to his wife, Mrs. Anne Sophia Laycock; and there are some specific gifts to his daughter and two grandsons. The residue of his real and personal estate he leaves upon trust for his wife for life, and then to pay £500 per annum to his daughter Clara Sophia Gill, and annuities of £30 each to his granddaughters. The ultimate residue is to be divided between all the children of his daughter.

A & S Henry & Co Ltd was founded in **1805** in Manchester by Alexander Henry in partnership with his brother Samuel. Their Uncle, Alexander Henry (born 1766 of Scottish parents), had emigrated to America from Ireland in 1783, establishing himself as a merchant in Philadelphia. The younger Alexander Henry also emigrated from Ireland and joined in his uncle's business but returned to England in 1804 rapidly establishing his company in marketing and distributing the products of the cotton industry from Manchester.enry & Co (Dundee) Ltd, to Asiatic Jute Co Boston, USA. The company expanded opening branch offices in Bradford, Belfast, Leeds, Huddersfield and Glasgow

to act as collecting stations for textile products of all kinds. In 1858 an office was opened in Dundee at 51 St Andrews Street although all business continued to be carried out through Glasgow until c.1903.


Anne Sophia LAYCOCK



Anne, Soho, Westminster. She was the daughter of **Henry** and **Anne Maria Grellier**, a Book Binder, of Gerrard Street. Henry Grellier himself had been born on 6 April **1801** to Peter and Sophia Grellier and was baptised at St. James, Piccadilly, on 3 May 1801. **Henry** married **Anne Maria Shinn** at St. Anne, Soho, by licence on 17 May **1828**. Henry died in the 3/4 quarter of **1871**, and was buried at Norwood Cemetery, Lambeth, on 22 September 1871.

Somewhere, somehow, John Laycock met Anna Sophia Grellier and they married in London on 14 July **1851** and moved to Manchester.

John Laycock's widow **Anne Sophia** survived him for 27 years and died on 19 July **1921**. By then, she had moved to live in St. Anne's on Sea. In the **1901** census, the record shows that she had already relocated to South Promenade, St. Anne's on Sea. She was living aged 72 on her own means, with her grandson Richard J. Gill, aged 27, and 2 servants. No trace has been found of her in the 1911 census.

Clara Sophia LAYCOCK

Clara Sophia Laycock was born on 14 May 1852. In the censuses of 1861 and 1871, she was living with her parents at ages 8 and 18. And then she married Richard Preston Gill at St. Mark's in 1872. Richard had been baptised at St. Michael in Alkrington on 1 May 1851.

One name that appears to be missing in 1881 was Jeannette Sophia, who was baptised at Holy Rood, Swinton, on 17 April 1879, having been born on 16 December 1878. Another missing name appears to be Thomas Henry Gill (26), since he married Sarah Elizabeth Lowe (23) by licence on 10 June 1903 at Christ Church, Sidcup, Kent. His father was Richard Preston Gill, Gentleman.

In **1885**, Richard Preston Gill appeared in the Electoral register, occupier of Hazlehurst Hall, Red Cat Lane, Worsley, at a rent above £50 per annum. Similarly, for 1889 - 1891, he owned a dwelling house The Poplars, 305 Worsley Road, and he was still there in 1895/5.

In **1901**, **Clara** was living at 13 Fairhaven Road at St. Anne's on Sea, aged 48, with Phoebe 18, Winifred 15, Mary G. 10, and 1 servant.

In **1911**, **Clara** was residing alone with a servant at 13 Fairhaven Road, St. Anne's on Sea. The details say that she was married and had had 11 children, one of whom had died. The house had 12 rooms.

GILL Clara Sophia of Anglehurst Fairhaven Lancashire (wife of Richard Preston Gill) died 24 November 1915 Probate London 14 January to Charles John Ernest Hall and James Hebert Brydon solicitors. Effects £516 19s. 8d.

GILL Richard Preston of Mid Illovo Central Natal South Africa died 18 December 1916 at Greip Hospital Pietermaritzburg South Africa Administration (with Will) Manchester 4 March to Frank William Gill manufacturer. Effects £194 4s. 11d.

Elsie Clara GILL

She was the third child and first daughter of Richard Preston Gill and Clara Sophia GILL (née Laycock). As the records show, she died on 2 October **1876**, aged 11 weeks, and was buried in the churchyard on 7 October 1875. Sadly, there is no record of a Baptism.
