




## **SARAH THOMAS**



The headstone for **Sarah Thomas** contains a few points of interest. Firstly, it is an elegantly carved stone, with a striking top piece. Worsley Secondly, it was erected mainly to her memory, with seemingly no other family members buried there. And lastly, the inscription to her son, George Louis Thomas, who died in Askland (?), Wisconsin, America, on 8 April **1895**, in his 22nd year. The inscription beneath her name reads: "Give her of the fruits of her hands and let her own works praise her in the gates". The inscription beneath the name of her son George reads: "For he hath delivered me out of all trouble".

We learn that **Sarah** was the widow of Henry George Thomas, of Finsbury Park, London. **Sarah** died on Christmas Day **1894**, aged 54 years. But who was she? What was her maiden name? Did she originate for some reason from London herself? Who and what was her husband? How come she was in London? And yet she was buried here? The surname Thomas posed several challenges. There was not a great deal of information to go on. So, research had to begin at the end, with George Louis Thomas, and work backwards.

From information found in reverse, we can conclude that Sarah was born **Sarah Edge**. Her parents were Richard Edge and Ellen Smith, and they were married at St. Mary, Eccles, on 22 September **1833**. She was baptised on 29 March **1840** at St. Stephen, Astley. Her father was a Labourer

The first national record showing **Sarah** with her parents is the census of **1841**. Their address was given simply as Boothstown, and within the household were Richard (12, an Ag. Lab.), Ellen (also 25), Betty (4), and **Sarah** (1).

Ten years later, the family had grown and we find:

Richard was by now a Butcher and the discrepancy in age is because in the 1841 census, for anyone over 15 or 20 their age was rounded downwards to the nearest five. So his likely year of birth would have been 1813. All children were recorded as being born in Worsley. William, Mary, Henry and Ann was all baptised at St. Mary, Ellenbrook,. Betty and **Sarah** were both baptised at St. Stephen, Astley.

As the next ten years passed, Richard may well have moved to become a farmer of 6 acres, though it seems he continued working as a Butcher, a trade followed by his son, William.

Peter was baptised at St, Mary, Ellenbrook. The two older girls, Betsey and **Sarah**, unsurprisingly were Cotton Weavers. And it is at this point that things started to become interesting. Richard had died just before the census of **1871** and was buried at St. Mark's. Ellen was head of the household, living at 23 Boothstown Lane, at Booth Villa. She continued her husband's work as a Butcher and of the family were living with her - Henry, Peter and Ann, all of whom were also Butchers. BUT Sarah was not there!

Burial: 28 March 1871. St Mark, Worsley.

Richard Edge Age: 58 yrs

Abode: Boothstown

Buried by: S. Vincent Beechey Vicar. (Plot C181).

Just to complete this side of the family's story, in **1881**, Ellen (68) was living at Rose Bank, Chaddock Road, Worsley, with Peter (29) married, his wife Annie (25 - born Anglesey), and on that day a niece Annie (2). Peter was still a Butcher but Ellen had retired. Ellen eventually died in **1888**.

Burial: 22 October 1888. St Mark, Worsley.

Ellen Edge - Age: 76 yrs.

Abode: Boothstown. (Plot C181).

The inscription on the Edge family headstone reads:

In affectionate memory of **RICHARD EDGE**, of Boothstown, who died March 24<sup>th</sup> **1871** aged 58 yrs. Also of **ELLEN** wife of the above who died October 18<sup>th</sup> **1888** aged 76 yrs. Also of **ANN** daughter of RICHARD & ELLEN EDGE who died February 20<sup>th</sup> **1876** aged 26 yrs. Also **HENRY** son of the above and beloved husband of SARAH EDGE who died July 10<sup>th</sup> **1917** aged 69 yrs. Also SARAH beloved wife of the above who died July 1<sup>st</sup> 192- aged 67 yrs. (C181)

So **Sarah** was not at the family home in Worsley in either 1871 or 1881. We know from the stone that she had been married to Henry George Thomas, of Finsbury Park, London. Details from the marriage certificate and from the 1871 census confirm that this was accurate. For they married at St. Luke, West Holloway, Islington, on 3 February **1864**, barely three years after the 1861 census. How she came to be there is a mystery. Her residence was given as 1 St. James Road and her father's name (Richard) and occupation (Farmer and Cattle Dealer) were both correct. Interestingly, **Henry George Thomas** was a Statuary Mason, like his father.

His father, George, was born in Churchill (or Churchend), Somerset, in c1805. He married Mary Ann Tabraham (of Tooting, Surrey) on 15 May 1826 at Old St. Pancras, London. They had 2 daughters and 3 sons, of whom **Henry George** was the eldest, born 1 July **1833**.

The other 4 children, Mary Ann (15 February 1827), Sarah (27 January 1830), William (1836) and George (1838) were all baptised at St. Mary, Islington. In each case, the father George was a Stone Mason, of Mason, or Statuary Mason.

In the **1851** census, we found the family at 12 Rutland Terrace, Islington.

Moving forward another ten years, in the next census we found:

So, having been married in 1864, we find **Henry George Thomas** and **Sarah** (Edge) with their young family living in Islington at the time of the **1871** census.

After seven years of married life, they had 4 children - Henry Edge was born 3 February 1865; Percy Brownwell was born 17 December 1866; Mary Ellen was born 4 September 1868; and Charles Richard was born 18 March 1870. All children were baptised at St. Mary, Islington. And **Henry George** was either a Sculptor or (Statuary) Mason.

When we look at the census for **1881**, we do not find Henry George. What we do see is that Sarah was the Head, a Widow.

Two distinct events clearly had occurred within the previous ten years. Firstly, three more children had been born. Sidney Herbert was born on 27 February 1872; **George Louis** was born on 15 September 1873; and Arthur was born on 30 May 1876. And secondly, **Henry George Thomas** had died. It is thanks to the *Index of Wills and Administrations* that we know the date of his death. He had died on 31 March 1880 at 27 Plimsoll Road, Finsbury Park, aged 47. To date, no trace had been found of where he was buried.

## WILL:

**THOMAS** Henry (otherwise **Henry George**) 30 April. Administration (with the will of the Personal Estate of Henry, otherwise Henry George, Thomas late of 27 Plimsoll Road, Finsbury Park, in the county of Middlesex, who died 31 March **1880** at 27 Plimsoll Road, was granted at the Principal Registry to **Sarah Thomas** of 27 Plimsoll Road, widow, the

relict, the Residuary Legatee for Life, if she remains a widow. Personal estate under £1,500.

By the time of the 1891 census, Sarah was on her own, with just 2 sons.

On Christmas Day **1894**, **Sarah Thomas** died. Did she die in London? If so, how come she was buried at St. Mark's?

There lies another mystery. She was buried in plot C34. The church grave record states that the owner of the plot was 'Exors. of the late Sarah Thomas, of Greyhound Inn, Boothstown.' Does this mean the Executors were of the Greyhound Inn, or does it refer to Sarah? Who then might the executors have been, since all her children had been born in London? Or if it was indeed Sarah of the Greyhound Inn, how and why did she manage to return to Worsley?



The burial record shows that she was buried just two days after her death; that this all happened over the festive period; and her 'abode' was Boothstown. So clearly, she must have relocated at some point in time.

Fortunately, she did leave a will and the index clearly states:

## WILL:

**THOMAS Sarah** of the "Greyhound" Inn, Boothstown, Worsley, Lancashire, widow, died 25 December **1894.** Probate LONDON 15 January to Henry Edge Thomas, Railway Clerk. Effects £741 1s. 8d.

But this does not answer how it was that she came back to her hometown. Surely not to manage an Inn?

The headstone is a fine piece of carving. It would have been fitting if one of the family had continued the work of a statuary mason, but there is no evidence of that. There has to be a reason for Sarah coming back north, and for the Greyhound Inn being linked with her. Work continues on that!.

[The stone stated that her son, George Louis, died at *Askland*, Wisconsin, America. That should have read *Askland*. It is the county seat of Askland County. The city (popn. 9,956 in 1900) is a port on Lake Superior. - Ed.]
