


## **Thomas BRADSHAW**

Thomas was, possibly, the son of John Bradshaw (1774 - 1839) and Sally Hilton (1779 - 1827). If this is correct, then **Thomas Bradshaw** was born on 6 July 1814 and then baptised at St. John, Manchester, on 11 August. John was a merchant and his address was St. John's Street, Manchester. He would have had a sister Harriet (born 1816) and a brother Edward (born 1819). An older sister, Sarah Ann, was buried on 12 January 1809, aged 5 months.

John was buried at St. Mary, Eccles, on 17 June 1839, (died 10 June), aged 64, by Rev. Thomas Blackburne, Rector of Prestwich. John's abode was Weaste House. John and Sally were married at Manchester Cathedral on 27 January 1803 by Isaac Brookes. John was 'of this town and parish' and was a merchant.

According to the baptism record for John *Gerald*, baptised at St. Mary, Eccles, on 6 July 1860, and born on 27 May **1860**, **Thomas Bradshaw**, father, was a Merchant, resident at Hope Field, Pendleton. Given that Thomas Bradshaw died on 27 April 1860, he would not have witnessed the birth of this his youngest child.

By the time of the **1871** census, both parents had died. The census for that year shows both John George and Frank Warrand as scholars at a boarding school at 9 Elliot Place, Lewisham. Katherine (Head, 24), Margaret Eliza (21), Amy Louisa (20), Frances Sophia Charlotte (17) and Annie Maud (14) were all living together at an address in Southwell, Notts. Katherine died in 1928. John Gerald died in 1931. Annie Maud died in 1933.

The tracing of this family has been very tricky and consequently the information is disjointed. Indeed, much of the information was not found in a logical sequence or time frame. The 1861 census has shown a Frances J. Houson, born Middlesex, just like Ann Isabel. And so, in attempting to present a picture of Ann Isabel's origins, and using this person, we find ..

*Joseph Howson* (45, solicitor); Sophia (40); *Frances* (20); Henry (15); Harry (14); Clay (11). Could this name be Housun?? The reference to 'Solicitor's daughter' above certainly helped.


Their marriage took place by Licence on 3 June **1845** at the Parish Church of Upper Chelsea. Thomas was of full age, Esquire. of Manchester in the county of Lancaster. Ann Isabel was a Minor, of Upper Chelsea. '*By consent of Joseph Houson, the natural and lawful father of the said minor*'.

The London Evening Standard on Thursday 5 June 1845 announced their marriage:

On the 3rd inst, at Trinity Church. St. Luke's, Chelsea, Thomas Bradshaw, of Hopefield, Lancashire, to Ann Isabel, daughter of Joseph Houson, Esq., of Lincoln's-inn-fields

They arrived at Pegg's Royal York Hotel, Brighton, that same evening. Their marriage was conducted by the Rev. J. H. Mapleton, rector of Aylton, and Thomas address was stated in the Evening Mail on the following Monday as Crumpsall Cottage, Manchester.



*The Manchester Courier* for Saturday 26 July **1845** reported that **Thomas Bradshaw**, of Hope Field, near Manchester, had been appointed too the provisional committee of the Manchester and Wigan Railway, with extension to Southport. He was just one of several cotton spinners appointed.

In January **1847**, it was reported that he had been appointed to a committee for one year of the Manchester and Salford Bank for Savings at its 29th annual meeting for Patrons. The Right Hon. Earl of Ellesmere was elected a vice-President for the ensuing year.

In its edition of Saturday 9 August **1851**, *The Manchester Courier* reported on the commencement of the General Quarter Sessions for the borough of Manchester. **Thomas Bradshaw**, of Artillery Street, merchant, was sworn in as Foreman of the grand jury.

Two reports in the London Gazette on 21 August 1855 announced the dissolution of partnerships.

NOTICE is hereby given, that the Partnership subsisting between us the undersigned, Thomas Bradshaw, James Hibbert Wanklyn, and Swinfen Jordan, heretofore carrying on business as Merchants, at Manchester and elsewhere, under the style or firm of Bradshaw, Wanklyn, and Jordan, this day ceased and determined by effluxion of time. Dated this 15th day of August, 1855. *Thomns Bradshaw. J. H. Wanklyn. Swinfen Jordan.* 

NOTICE is hereby given, that the Partnership subsisting between us the undersigned Thomas Bradshaw and James Hibbert Wanklyn, heretofore carrying on business as Merchants, at Manchester and elsewhere, under the style or firm of Bradshaw, Wanklyn, and Sons, was this day dissolved by mutual consent. Dated this 16th day of August, 1855. *Thomas Bradshaw*.

After the death of Thomas Bradshaw, a further announcement appeared in the *London Gazette* on 5 October **1860.** 

NOTICE is hereby given, that the Partnership subsisting between us the undersigned, Ann Isabel Bradshaw, as Executrix of Thomas Bradshaw, deceased, and Swinfen Jordan, heretofore carrying on business as Merchants, at Manchester and elsewhere, under the style or firm of Bradshaw, Jordan, and Co., was and is dissolved by mutual consent, as on and from the 30th of September last. Dated this 1st day of October, 1860. *Swinfen Jordan.* Ann Isabel Bradshaw, Executrix of *Thomas Bradshaw*,

Ann Isabel Houson, was born on 20 October 1827 and baptised on 5 March 1828 at St. George, Bloomsbury, Camden. Her father was Joseph, Solicitor, (1793, Southwell, - Croydon, 1876) of Gower St., St. Giles, and her mother was Sophia Catherine (1799 - London, 1842).



Her parents Joseph and Sophia Catherine (Tuckett) married at St. Giles in the Fields, Holborn, on 25 May **1819**.

## The Business

It is still unclear as to what kind of merchant precisely **Thomas Bradshaw** was. However, a reference to the firm appears in a book: "When Charles Darbyshire joined the firm of Bradshaw, Wanklyn and Jordan in Buenos Aires as a clerk in 1852, he reported only a dozen British businesses in the city". *(The British in Argentina; Commerce, Settlers and Power -* by David Rock 2018). It may have been connected to wool.

Further reference to this firm appears in "*The organisation of British textile exports to the River Plate and Chile: Merchant houses in operation, c. 1810–59 - by Manuel Llorca-Jana. October 2011*" where it records "Bradshaw, Wanklyn and Jordan. Buenos Aires, Montevideo, Rio de Janeiro. 1830s, 1840s". [From a biography of William Wanklyn]

It is said that John Bradshaw, a Manchester merchant travelling on business met William and took a fancy to the young man and took him back to Manchester and into his business in 1796 or 97. William married the boss's daughter.

He founded the trading business of Guillermo (William) Wanklyn which used to receive shipments of imported goods. In 1821 William's business, that was now called Hibbert, Wanklyn & Bradshaw was one of the founding financiers of the first Protestant cemeteryel Socorro. William had left Buenos Aires by 1822, the year in which John Robinson was his agent in the country. In 1837 his business continued operating in Montevideo as Bradshaw, Wanklyn & Sons, one of the financial supporters of the Protestant cemetery in that city. Shortly afterwards the business changed its name to Bradshaw, Wanklyn & Jordan whose agents, until 1849, in Buenos Aires were Plowes, Atkinson & Co. In March 1849 the business returned to Buenos Aires and established itself at 72 Reconquista with William's grandchildren in charge.

PROPOSED MONUMENT TO THE LATE DUKE OF WELLINGTON

We stated yesterday that a meeting had been held at Manchester to consider the propriety of erecting a permanent memorial of the late Duke of Wellington, and that certain subscriptions bad been announced. We find that the following noblemen antl gentlemen had subscribed  $\pm 100$  each before the meeting.

In addition to the [2nd] Earl of Ellesmere, the firm of Bradshaw, Wanklyn and Jordan made a sunscription.

The Manchester Courier on Saturday 4 November **1854** reported on a Public Meeting held in Manchester two days earlier and convened by the Mayor, calling upon Merchants, Bankers, Tradesmen and other inhabitants to show their satisfaction at the appointment by her Majesty of a Royal Commission to accept contributions to a Patriotic Fund. Its purpose was to apply support to the widows and orphans of the soldiers, sailors and marines who had fallen or who had become casualties of war. Again, the firm donated £100.
